# CALL TO ORDER

The meeting was called to order by Director Jezioro at approximately 1:10 p.m. The director welcomed everyone attending and asked everyone to introduce themselves.

### APPROVAL OF MINUTES

Commissioner Garten made a **MOTION** to approve the minutes of the June 21, 2007, and August 22, 2007 meetings as submitted. The motion was seconded by Commissioner Johnson. The motion passed as submitted.

#### PUBLIC COMMENT

Erick Pories, WVPRO, stated fall trout stocking will be October 16, 2007, will be stocking 2,000 pounds. A helicopter has been secured, asked if anyone has information on vendors for helicopters he would appreciate the information.

### **REGULATIONS SUB COMMITTEE**

Commissioner Danz would like for the sub committee to look at penalties. He would like a different penalty structure for guides. Asked DNR to provide a bullet list of qualifications for guides, the regulations are too confusing. Commissioner Johnson stated that penalties are set by code, does not know how to change. Will Valentino will check to see what procedure needs to be make changes.

Commissioner Proctor would like to have training at the beginning of season with law enforcement officers and outfitters to review the guidelines and laws to have a clear understanding of how DNR will enforce laws.

Larry Case stated that if the companies would let him know the dates and locations of their meeting with the river guides he would have an officer attend the meeting.

#### LAC SUBCOMMITTEE REPORT

Commissioner Proctor spoke to Chip Short and hopes to have trip leader report for the next meeting. Committee worked with Andy Whisman in the past on inconsistency of reporting. Commissioner Proctor submitted a draft of wording he feels would clear up the language concerning medical services and medical facility on the Whitewater Accident Report. (Attachment A)

#### **BUDGET SUBCOMMITTEE REPORT**

Paul Hart reviewed the budget. Stated he needed to contact Keith Wilson as to when the budget is due. (Attachment B)

Director Jezioro questioned how the season is going? Commissioner Johnson stated flat or down, Commissioner Proctor reported as being flat.

#### TOURISM SUBCOMMITTEE REPORT

Erick Pories reported Tourism Commission meeting September 20, 2007, will have report later. Commissioner Carver recommended rescheduling for the November 5<sup>th</sup> meeting.

Commissioner Danz stated he is working with Sharon Cruickshank with the CVB in whitewater regions. Betty Carver stated she would be happy to work with Commissioner Danz and the CVB.

Next year is the 40<sup>th</sup> year anniversary of Whitewater. Commissioner Carver requested Commissioner Danz and Commissioner Johnson be appointed to work with Tourism on the Whitewater Rafting Anniversary season.

# OTHER BUSINESS

Jeff Proctor mentioned the application from Elk Hill's, it was received on March 29, 2007, and the deadline was March 15<sup>th</sup>. Sub committee will act as soon as possible. Elk Hill's is requesting a new license. Director Jezioro asked them to review and let us know at the next meeting.

Director Jezioro asked for a report on the Whitewater Performance Audit Commissioner Danz reported that the meeting was held in Martinsburg, West Virginia. Auditors did not understand and there is lot of confusion. Safety was an issue. Auditors stated a Safety Committee needed to be formed. Commissioner Danz stated it is up to the commission to form a Safety Committee. Commissioner Proctor made a **MOTION** to form a Safety Committee. Commissioner Beyer seconded. The motion passed. Commission Proctor stated that is one of the tasks Andy Whisman was working with Chip Short to generate a report. Commissioner Proctor stated there is confidentiality involved and asked if DNR could compile a report. Larry Case thought the outfitters wanted the online accident report. It was determined that Commissioner Proctor, Will Valentino and Chip Short will work on the changes and design a report. Director Jezioro stated it is not necessary to go into detail on the report with the possibility of public accessibility. Erick Pories suggested getting legal opinion on how detail the report should be. Performance Auditors are also requesting an accident report be generated. Commissioner Danz stated the auditors used AWA information which is nationwide survey. Commissioner Proctor asked do the auditors want a report for statistics, injuries classified by type, the number of rafters falling out of the raft, general accidents or

acknowledging all the above are accidents and need to be on the report. The auditors also stated the commission can not use a proxy. If a commissioner is not available to attend a meeting in person they may participate by conference call. The audit results also found that the minutes from past commission meetings were not on the website. Lt. Col. Jerry Jenkins stated that minutes from past meetings are now on the website except for a couple of the meetings.

Mike Hunter, National Park Service, stated they are planning a general management meeting
