### Call to Order

The Whitewater Commission meeting of June 16, 2022 was called to order at 2:07 p.m. by Lt. Col. David Trader. Introductions were made.

## **Approval of Minutes**

Motion was made to approve minutes from the June 7, 2022, meeting by Bobby Bower. Chris Hayes seconded. Motion carried.

#### **New Business**

- The purpose of this special meeting was to discuss changes to 58CSR12. Discussion was held on the following sections: 3.1.3.g; 3.1.5; 3.1.5.c; 5.3 (grammar); 9.11; 9.12 (add guide qualifications); 9.12.3.a; 9.12.3.c; 9.12.5; 11.2 (clarification); 12.1.1 (clarification); 12.1.4 (eliminated Lake and added Dam); 12.1.5; 14.1.2; 58-12-14 (added whitewater zones); 14.2.1; 14.2.2; 14.3.1; 14.3.2; 14.4.2; 14.5.1; 14.8
- Lt. Col. Trader proposed a study group during public comment period.
- Discussion was made about Tygart Lake being all flat water. The Commission prohibits rentals in whitewater zones.
- Wendy Greene explained the process of Public Comment and Final File. The public comment period is for thirty days. Final filing would be July 29, 2022.
- Motion to approve rules as discussed so that it can move forward for public comment was made by Chris Hayes. Motion was seconded by Ed Wooton. Motion carried.
- No motion made to form a committee for discussion.
- Wendy Hart explained the areas of the Cheat River. There is a section where it is not true whitewater, as there is a low-head dam. There is talk that in later years the dam may be removed and individuals may want to start renting kayaks, floats, stand-up paddle boards.
- Bobby Bower discussed wanting to be able to open up boat rentals on Hawks Nest Lake. More discussion was made on section 14.5.1.
- Motion was made to hold a tentative meeting should public comments be received on July 25, 2022 at 1:00pm by Bobby Bower. Motion seconded by Wendy Hart. Motion carried. If no public comments are received, the agency can move forward with the rule making process.
