Call to Order

Whitewater Reporting – Injury Reports – Injury Report Summary

Heather Kessel explained that she had worked on getting all injury reports from 2011 to the present entered correctly in the whitewater database. She mentioned that outfitters had been cooperative and helpful getting missing injury reports into the system.

She presented a *Memorandum of Agreement* (MOA) from the WV Office of Technology (WVOT) to perform basic weekly tasks, to the reporting system, without drawing up a contract each time something minor needed performed. The MOA allows WVOT preauthorization to perform tasks at no more than \$3,600 per month and only charges for services rendered.

Roger Wilson made a motion to agree to the terms of the MOA with the understanding that a billing summary is provided monthly by WVOT. Motion seconded by Rick Johnson. The motion carried.

Tygart River Zone Evaluations

Colonel Jenkins asked the members if anyone have been on the Tygart and evaluated the zones mentioned in the last meeting in regards to "flat water". Brian Campbell mentioned that he had spoken with someone that knows the area and the section has low water levels most of the time.

It was decided to run the section at different water levels and determine the guest ratio. Colonel Jenkins agreed to assign Natural Resources Police Officers to help evaluate the section and Commission members offered to assist. Bobby Bowers and Heather Kessel will schedule dates and notify the Commission.
