#### Call to Order

The Whitewater Commission meeting of June 9<sup>th</sup>, 2015 was called to order at 1:09 p.m. by Colonel Jerry B. Jenkins. Introductions were made. Attendance sheet provided for attendees to sign.

# Approval of March 10<sup>th</sup>, 2015 Minutes

Chris Ellis made a motion to approve the minutes from the March 10<sup>th</sup>, 2015 meeting. Motion seconded by unknown member. The motion carried.

#### **Budget**

Matt Knott (by phone) advises that income is slightly under what expected and expenses are down due to the change in the administrative fees by DNR.

## **Rule Changes**

Colonel Jenkins explains that the most important change to the rule is that tubes/other craft can be used in two whitewater zones. Also, that general outfitter & guides are now required to pay the user fees when on whitewater zones.

Heather Kessel mentioned that the mass mailing concerning the new rule and reporting requirements was sent to all whitewater outfitters and general outfitters.

## **Whitewater Website**

The new website, including enhancements, has not been tested enough to release into production. Once testing is complete and WVDNR is satisfied the system will work sufficiently the site will go into production and can be used by outfitters.

### **Other Business**

Skip Heater, NGRA, expressed concerns about WVDNR Police Officers conducting checks on the river and suggested that it may be best to do the checks back at basecamp instead. He mentioned that it's impossible to have all the necessary credentials out on the river. Colonel Jenkins explains that the officers most often

check equipment and safety issues on the river to assure that all is in order. Colonel Jenkins advised Skip that he'd check with those district officers to determine the specifics of the checks.

Jerry Cook expressed concern that there are a number of "whitewater pirates" representing themselves as licensed whitewater outfitters when they are indeed not licensed. Colonel Jenkins advised that if the persons are advertising as whitewater outfitters, then they are required to have a license. He assured the Commission his office would check into these outfits and encouraged everyone to report other instances of "pirating".

Jerry Cook asked if anyone at the Commission knows where the advertising funds would be allotted to. There was discussion that Tourism had ran several commercials and it was believed those were developed with advertising funds.
